The proposal that our area drafted regarding how voting works at the RSC was passed with 100% of areas in the region assenting. Thank you all for your hard work and input in that process. This means that the areas (represented by their RCMs) each have a voice under CBDM during final decision making. Anyone can participate in discussions, and anyone can bring proposals etc., but final decisions are made by the areas. There was some back and forth in new business regarding whether RCMs should be able to simultaneously serve in the regional administrative body or as a subcommittee chair at region. Proposals were made to prevent RCMs from serving in those positions simultaneously out of a concern that there may be conflicts of interest, but those proposals did not pass. The consensus was that RCMs should be able to serve at region (similar to how our area allows GSRs to serve in the area administrative body simultaneously), and that since there would be no 'double dipping' regarding voting, there was no conflict of interest.

An important note is that TBRNA is navigating some major financial struggles, so any donations are appreciated. There are several open positions at region: co-recorder, policy chair, and treasurer. Please come to the next RSC if you're interested in serving in any of those roles. - Beginning Inventory: \$4085.00
- Please announce that the Area Literature Co-Facilitator position will be open at the beginning of the new year.
- Please pay by Money Order, or Cash under \$25 (Exact change).
- Lit Bank opens before Area begins (typically around 1:30 pm), and runs through the opening half of Area.
- Once Lit Bank is done processing all the orders, and turns money over to the Treasurer, Lit Bank is then closed - in order for Inventory may be taken.
- If you have not received your order by the end of Area please come pick up your filled order at the literature.
- Our goal is to simplify Lit Bank operations, therefore 70+% of the work will be carried out on the day of Area.
 - We will only fill orders first half of Area
 - We will typically process the NAWs order on the day of Area (or within a reasonable time frame).

We met on Tuesday, Dec 2nd, with 5 people in attendance. We were joined by Lou, from PR Newsletter sub committee to discuss CW submissions moving forward. Submissions will surround tips and practical applications to keep building a culture of safety at home groups. We also discussed the transition to Leanne M. as Facilitator and Jim F. as Co-Facilitator, following today's vote at Area.

We received the My Safety, Our Responsibility pamphlets and will be handing those out to any meetings that want them at Area. If your group is unable to attend Area, and you would like copies of the pamphlet for your group, please message me directly, and we will figure out how to get them to you. Any leftover pamphlets will be given to the Lit Bank for meetings to request more in the future. Just a reminder, once these 500 copies run out, your group will be responsible for printing the pamphlets on your own, should you so choose.

I have had the honor of serving as Co-Facilitator—and later Facilitator—since CW's creation in 2022, and I am incredibly proud of what we have accomplished together. But our work is far from finished. As World has emphasized, predatory and disruptive behavior in our meetings remains the number one threat to our fellowship's future.

Around the globe, trusted servants are writing new literature and developing tools to address these issues. Much of this guidance is available on [NA.org](https://www.naaf.org), and I've included a link below. Our Area was the first to be forward-thinking and courageous enough to form a subcommittee dedicated to this sensitive, but critically important, issue. Since then, areas across the country have reached out asking how we did it and expressing their own need for similar support.

Let me be clear: this is not about surveillance, judgment, or policing personal relationships. This is about ensuring that every member—newcomer or old-timer—feels safe, respected, and welcome in any meeting they attend. Our primary purpose is compromised the moment a newcomer witnesses or experiences a culture of silence in the face of harmful behavior.

I implore this Area to stay engaged in this conversation: attend the subcommittee meetings, bring your experience and voice, and speak up when you see behavior that threatens the safety of our spaces. We cannot afford to look the other way anymore.

Common Welfare meets on Zoom at 6 pm the Tuesday before Area. Our next meeting will be on Tuesday, December 30th. The link can be found in the calendar at ctana.org.

- Geo completed the transition from phone.com to YAP (Yet Another Phoneline), provided to us by the same group of NA members who have provided our meeting list and meeting lookup services for many years. The only cost we will incur will be a minimal charge for the help line number (\$1.15/mo) and actual usage charges which are expected to average around \$5/mo to \$8/mo based on actual usage for November. Phone.Com billing has been around \$35/mo for some time. We have been using the new help line for several months; calls to 512-480-0004 (our traditional help line) have been forwarded from Phone.Com to YAP. Those calls are now going directly to YAP, bypassing Phone.Com. At the last ASC, I reported that we were experiencing significant issues moving the actual number to YAP, however those issues have been resolved and our help line number will stay the same in YAP. The Toll Free number, 866-792-8262, has been abandoned in order to make the best use of our resources, as previously discussed with the ASC. Until our current billing cycle ends on December 17th, callers will receive a forwarding message asking them to call the 512-480-0004 number. I feel that is a better option than



continuing to forward it to YAP and then have it just stop working on the 17th with no notice in case members are still using it. Note that we have been incurring charges ranging from \$0.19 to \$0.95 per minute for each call made through the 800 number, as well as a charge to have the number in service. All web site references to the toll free number have been removed. The forwarding message is: "Thank you for calling Central Texas Area of Narcotics Anonymous. This number is no longer in service. To reach our help line, please call 512-480-0004. Again, that number is 512-480-0004. We look forward to speaking with you soon." Now that the 512 number has been transferred to YAP, we are working to resolve regulatory issues to allow us to enable SMS (text messaging) for the YAP service, which will allow us to provide even more modern services to our callers. Current services include:

- o Connection to live helpline volunteers in both English and Spanish
- o A flexible scheduling system that allows our coordinator to assign hours based on volunteer availability rather than fixed time slots
- o Ability to leave voice mail which will be sent to the Phone Line coordinator and can be forwarded by him as needed.

- o Ability for callers to look up and receive schedule and location info for nearby meetings. Soon, request and receive that information via text message.

- o Integration with our Meeting Database. When the Webmaster updates meeting information, the same data available to the website is used by YAP.

- o Ability to hear the Just For Today or Spiritual Principle For The Day.

- o Reports and Analytic Tools to help the Coordinator better manage the help line.

- o Better ability to back up volunteer information and schedules to respond to system failures.

- This took tremendous effort and diligence! THANK YOU, GEO!

- Geo also configured a Spanish Welcome text for YAP after the language option.
